As for several other pathogens, it is possible that lipoproteins of *C. difficile* may play a role in adherence of this bacterium. The consensus sequence depicted at the bottom is a WebLogo consensus generated from the ClustalW alignment of the lipobox from 25 *C. difficile* lipoproteins. The consensus depicts the invariant nature of a cysteine within this motif. The background is also overlaid with a ribbon image of LolA from *Escherichia coli* generated from the Protein Data Bank structure file 1IWL using the PyMOL molecular graphics system.
